



The relative strengths and weaknesses of Monte Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 119% points. The greatest weakness of Monte Hochbau GmbH is the variable Inventories, reducing the Economic Capital Ratio by 1.008% points.

The company's Economic Capital Ratio, given in the ranking table, is 352%, being 73% points above the market average of 279%.
