

#### Hanova Gewerbe GmbH Rank 100 of 116

The relative strengths and weaknesses of Hanova Gewerbe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Due After More Than 1 Year, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 188%, being 91% points below the market average of 279%.
