

Stuckert Wohnbau

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Inventories Remainder, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is 281%, being 2,3% points above the market average of 279%.
