

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Due Between1 And5 Years, increasing the Economic Capital Ratio by 1.009% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 1.543% points.

The company's Economic Capital Ratio, given in the ranking table, is 1.009%, being 748% points above the market average of 260%.
