

The relative strengths and weaknesses of Matthias Ruppert Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Matthias Ruppert Bauunternehmen GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Matthias Ruppert Bauunternehmen GmbH is the variable Orders In Progress, reducing the Economic Capital Ratio by 43% points.

The company's Economic Capital Ratio, given in the ranking table, is 314%, being 54% points above the market average of 260%.
