



The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Rensch Haus GmbH is the variable Buildings On Third Party Land, reducing the Economic Capital Ratio by 27% points.

The company's Economic Capital Ratio, given in the ranking table, is 320%, being 59% points above the market average of 260%.
