

Hanova Services GmbH Rank 5 of 113

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Partial Profit Transfer Agreements, increasing the Economic Capital Ratio by 644% points. The greatest weakness of Hanova Services GmbH is the variable Prepayments And Assets Under Construction, reducing the Economic Capital Ratio by 17.971% points.

The company's Economic Capital Ratio, given in the ranking table, is 644%, being 348% points above the market average of 296%.
