

The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Due Within1 Year, increasing the Economic Capital Ratio by 17% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Payments On Account, reducing the Economic Capital Ratio by 16% points.

The company's Economic Capital Ratio, given in the ranking table, is 277%, being 10% points above the market average of 267%.
