

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Orders In Progress, increasing the Economic Capital Ratio by 181% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 107% points.

The company's Economic Capital Ratio, given in the ranking table, is 184%, being 83% points below the market average of 267%.
