

#### Bateg GmbH Rank 7 of 109

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 42% points. The greatest weakness of Bateg GmbH is the variable Finished Goods, reducing the Economic Capital Ratio by 466% points.

The company's Economic Capital Ratio, given in the ranking table, is 298%, being 31% points above the market average of 267%.
