



The relative strengths and weaknesses of MSB Bauausführungen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MSB Bauausführungen GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 103% points. The greatest weakness of MSB Bauausführungen GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 78% points.

The company's Economic Capital Ratio, given in the ranking table, is 268%, being 0,76% points above the market average of 267%.
