

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 26% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Bank Balances And Cheques, reducing the Economic Capital Ratio by 18% points.

The company's Economic Capital Ratio, given in the ranking table, is 274%, being 7,4% points above the market average of 267%.
