

#### Moser GmbH Co KG Rank 109 of 109

The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 0,63% points. The greatest weakness of Moser GmbH Co KG is the variable Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, reducing the Economic Capital Ratio by 1.310% points.

The company's Economic Capital Ratio, given in the ranking table, is 1,2%, being 266% points below the market average of 267%.
