

SEH Engineering GmbH Rank 58 of 109

The relative strengths and weaknesses of SEH Engineering GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SEH Engineering GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 18% points. The greatest weakness of SEH Engineering GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 31% points.

The company's Economic Capital Ratio, given in the ranking table, is 256%, being 11% points below the market average of 267%.
