

VSTR AG Rodewisch Konzern Rank 25 of 109

The relative strengths and weaknesses of VSTR AG Rodewisch Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch Konzern compared to the market average is the variable Due Within1 Year, increasing the Economic Capital Ratio by 17% points. The greatest weakness of VSTR AG Rodewisch Konzern is the variable Payments On Account, reducing the Economic Capital Ratio by 15% points.

The company's Economic Capital Ratio, given in the ranking table, is 276%, being 8,5% points above the market average of 267%.
