

BMS Industriebau GmbH Rank 74 of 108

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 132% points. The greatest weakness of BMS Industriebau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 64% points.

The company's Economic Capital Ratio, given in the ranking table, is 235%, being 20% points below the market average of 256%.
