The greatest strength of Koska Bau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 866% points. The greatest weakness of Koska Bau GmbH is the variable Liabilities Of Which Due Within1 Year, reducing the Economic Capital Ratio by 418% points.

The company's Economic Capital Ratio, given in the ranking table, is 971%, being 715% points above the market average of 256%.
