

The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 92% points.

The company's Economic Capital Ratio, given in the ranking table, is 326%, being 71% points above the market average of 256%.
