

# MSB Bauausführungen GmbH Rank 82 of 110

The relative strengths and weaknesses of MSB Bauausführungen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MSB Bauausführungen GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 61% points. The greatest weakness of MSB Bauausführungen GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 47% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 32% points below the market average of 243%.
