

BMS Industriebau GmbH Rank 89 of 115

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 87% points. The greatest weakness of BMS Industriebau GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 109% points.

The company's Economic Capital Ratio, given in the ranking table, is 198%, being 51% points below the market average of 249%.
