


KNOBEL BAU





Knobel BAU GmbH Rank 97 of 115

The relative strengths and weaknesses of Knobel BAU GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Knobel BAU GmbH compared to the market average is the variable Inventories Gross Before Deduction Of Prepayments, increasing the Economic Capital Ratio by 162% points. The greatest weakness of Knobel BAU GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 120% points.

The company's Economic Capital Ratio, given in the ranking table, is 162%, being 86% points below the market average of 249%.
