

The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Work In Progress Contracted Construction In Progress, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 41% points.

The company's Economic Capital Ratio, given in the ranking table, is 190%, being 58% points below the market average of 249%.
