

# Reuter Bauunternehmen GmbH Rank 83 of 115

The relative strengths and weaknesses of Reuter Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Reuter Bauunternehmen GmbH compared to the market average is the variable Receivables And Other Assets Other Assets, increasing the Economic Capital Ratio by 135% points. The greatest weakness of Reuter Bauunternehmen GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 170% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 27% points below the market average of 249%.
