

The greatest strength of HBG Bau GmbH compared to the market average is the variable Liabilities To Affiliated Companies, increasing the Economic Capital Ratio by 0,15% points. The greatest weakness of HBG Bau GmbH is the variable Liabilities Of Which Due Within1 Year, reducing the Economic Capital Ratio by 669% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,15%, being 248% points below the market average of 249%.
