

Ulrich Reitenberger Bau GmbH Rank 20 of 116

The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 135% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Inventories Prepayments, reducing the Economic Capital Ratio by 218% points.

The company's Economic Capital Ratio, given in the ranking table, is 303%, being 49% points above the market average of 254%.
