The greatest strength of Moser GmbH Co KG compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 420% points. The greatest weakness of Moser GmbH Co KG is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 203% points.

The company's Economic Capital Ratio, given in the ranking table, is 420%, being 166% points above the market average of 254%.
