

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 99% points.

The company's Economic Capital Ratio, given in the ranking table, is 277%, being 19% points above the market average of 258%.
