

Arning Bauunternehmung

The relative strengths and weaknesses of Arning Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH Konzern compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Arning Bauunternehmung GmbH Konzern is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 132% points.

The company's Economic Capital Ratio, given in the ranking table, is 275%, being 17% points above the market average of 258%.
