

Krüger Bau Bernau GmbH Rank 104 of 113

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 13% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 116% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 142% points below the market average of 243%.
