



The relative strengths and weaknesses of Bauunternehmung Albert Weil Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 23% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 22% points below the market average of 243%.
