

BMS Industriebau GmbH Rank 3 of 109

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 200% points. The greatest weakness of BMS Industriebau GmbH is the variable Inventories Remainder, reducing the Economic Capital Ratio by 222% points.

The company's Economic Capital Ratio, given in the ranking table, is 371%, being 129% points above the market average of 242%.
