

Markgraf Familien GmbH Rank 51 of 109

The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Markgraf Familien GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 84% points.

The company's Economic Capital Ratio, given in the ranking table, is 264%, being 22% points above the market average of 242%.
