



The relative strengths and weaknesses of Ruben Schäfer Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Work In Progress Orders In Progress, increasing the Economic Capital Ratio by 177% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 166% points.

The company's Economic Capital Ratio, given in the ranking table, is 177%, being 65% points below the market average of 242%.
