

#### Schrobsdorff Bau Aktiengesellschaft Rank 31 of 109

The relative strengths and weaknesses of Schrobsdorff Bau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Bau Aktiengesellschaft compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Schrobsdorff Bau Aktiengesellschaft is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 72% points.

The company's Economic Capital Ratio, given in the ranking table, is 273%, being 31% points above the market average of 242%.
