

#### Schrobsdorff Holding AG Rank 44 of 109

The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Schrobsdorff Holding AG is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 85% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 25% points above the market average of 242%.
