

#### Stuckert Wohnbau Aktiengesellschaft Rank 69 of 109

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 78% points.

The company's Economic Capital Ratio, given in the ranking table, is 244%, being 2,1% points above the market average of 242%.
