

### Ortwin Goldbeck Holding SE Rank 40 of 43

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Receivables From Affiliated Companies, increasing the Economic Capital Ratio by 26% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Stockholders Equity, reducing the Economic Capital Ratio by 110% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 122% points below the market average of 231%.
