

Bien Zenker GmbH Rank 93 of 108

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Goodwill, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Bien Zenker GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 97% points below the market average of 256%.
