

### Ulrich Reitenberger Bau GmbH Rank 2 of 110

The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 368% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 343% points.

The company's Economic Capital Ratio, given in the ranking table, is 616%, being 373% points above the market average of 243%.
