

## ANES Bauausführungen Berlin GmbH Rank 73 of 110

The relative strengths and weaknesses of ANES Bauausführungen Berlin GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ANES Bauausführungen Berlin GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 53% points. The greatest weakness of ANES Bauausführungen Berlin GmbH is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is 244%, being 0,63% points above the market average of 243%.
