

### VSTR AG Rodewisch Rank 61 of 110

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 44% points. The greatest weakness of VSTR AG Rodewisch is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 260%, being 17% points above the market average of 243%.
