



The relative strengths and weaknesses of Matthias Ruppert Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Matthias Ruppert Bauunternehmen GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 44% points. The greatest weakness of Matthias Ruppert Bauunternehmen GmbH is the variable Liabilities To Affiliated Companies, reducing the Economic Capital Ratio by 45% points.

The company's Economic Capital Ratio, given in the ranking table, is 255%, being 12% points above the market average of 243%.
