

## Fritz Meyer GmbH Bauunternehmung Rank 31 of 115

The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 58% points.

The company's Economic Capital Ratio, given in the ranking table, is 276%, being 27% points above the market average of 249%.
