

#### Markgraf Familien GmbH Konzern Rank 87 of 115

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 46% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Work In Progress, reducing the Economic Capital Ratio by 5.194% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 37% points below the market average of 249%.
