

### Markgraf Familien GmbH Rank 42 of 116

The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Markgraf Familien GmbH is the variable Fixed Assets, reducing the Economic Capital Ratio by 123% points.

The company's Economic Capital Ratio, given in the ranking table, is 272%, being 18% points above the market average of 254%.
