

#### Bien Zenker GmbH Rank 88 of 116

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Bien Zenker GmbH is the variable Liabilities To Affiliated Companies, reducing the Economic Capital Ratio by 27% points.

The company's Economic Capital Ratio, given in the ranking table, is 220%, being 34% points below the market average of 254%.
