



The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 55% points. The greatest weakness of VSTR AG Rodewisch is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 109% points.

The company's Economic Capital Ratio, given in the ranking table, is 292%, being 34% points above the market average of 258%.
