

Otto Wulff Bauunternehmung GmbH Rank 31 of 116

The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 107% points.

The company's Economic Capital Ratio, given in the ranking table, is 289%, being 31% points above the market average of 258%.
