

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 95% points.

The company's Economic Capital Ratio, given in the ranking table, is 270%, being 12% points above the market average of 258%.
