

Schrobsdorff Holding AG Rank 61 of 116

The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Schrobsdorff Holding AG is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 93% points.

The company's Economic Capital Ratio, given in the ranking table, is 267%, being 9,6% points above the market average of 258%.
